

**VGH & UBC HOSPITAL FOUNDATION:  
VITAL MAGAZINE SURVEY DRAW CONTEST**

**OFFICIAL CONTEST RULES NO PURCHASE REQUIRED**

**1. CONTEST PERIOD:**

VGH & UBC Hospital Foundation (“The Foundation”) Vital Magazine Survey Draw Contest (the “Contest Rules”) begins on October 6, 2023 at 8:00 a.m. Pacific Time (“PT”) and ends on December 6, 2023 at 11:59 p.m. PT (the “Contest Period”).

**2. ELIGIBILITY:**

**NO PURCHASE REQUIRED.** The Contest is open to all legal residents of British Columbia who have reached nineteen (19) years of age at the time of entry and otherwise comply with these Official Contest Rules (the “Contest Rules”). Employees of The Foundation, its affiliates, advertising and promotional agencies and the immediate family and household members of those persons are not eligible.

**3. HOW TO ENTER:**

**NO PURCHASE REQUIRED.** To enter for a chance to win, complete one (1) following step during the Contest Period:

(a) Complete the Vital Magazine Survey found at <https://vghfoundation.ca/vital-magazine-survey/> in full.

**Anyone who carries out the above and complies with the Contest Rules will be entered for a chance to win. All Contest entries must be received by the end of the Contest Period. All entries become the property of The Foundation and will be stored and destroyed in compliance with the Freedom of Information and Protection of Privacy Act. The Foundation is not responsible for and accepts no liability for late, lost, misdirected, delayed, or incomplete entries.**

**4. PRIZES:**

**The Prize: There is three (3) prize available to be won.**

- One (1) \$50 gift card to Toptable
- One (1) \$50 gift card to Tractor
- One (1) \$50 gift card to Dollarama

Prizes are not transferable and must be accepted as awarded with no substitutions in cash or otherwise. The Foundation reserves the right, in the event that any prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize or component of a prize of equal or greater value, without liability. **LIMIT ONE (1) PRIZE PER HOUSEHOLD.** Prizes are subject to any terms, conditions, and restrictions imposed by their issuer or manufacturer.

**5. WINNER SELECTION:**

A random draw will be conducted on or around December 7, 2023 by The Foundation to select Three (3) entrants from all eligible Contest entries from the Vital Magazine Survey to each win a prize. Before being declared a winner, The Foundation will contact the selected entrants, who will be required to (a) correctly answer a mathematical skill-testing question and (b) sign and return a Declaration, Consent and Release form to receive the prize. At least two (2) attempts will be made over the two (2) days following the draw to contact the selected entrant. If a selected entrant cannot be contacted, fails to correctly answer the

skill-testing question, fails to complete and return the Declaration, Consent and Release form within the five (5) business days after being contacted, or cannot accept the prize for any reason, then at The Foundation's sole discretion, that entrant will be disqualified and another entrant will be selected by random draw from remaining eligible entries.
